THE SCHOOL BOARD TICKET

(Vote for Five)

Mrs. Maud Miller—Indorsed by the nonpartisan citizens school committee and many other civic organizations for school commissioner to take office January 1, 1930, for four years. Born in Anderson in 1855, she attended Indiana University and then came to Indianapolis where she was married to Dr. J. Don Miller, now associate professor of pediatrics at Indiana University, and acting head of the Riley Hospital. Before her marriage, Mrs. Miller taught school at Anderson and Wabash. She has two children, a daughter in grade school and a son in Shortridge High School. She is a member of the Tabernacle Presbyterian church, an officer in School 'A, Parent-Teacher Association and in the Indianapolis Federation of Parent-Teacher Associations. Mrs. Miller lives at 2142 Broadway.

Julian Wetzel—Candidate for position to be filled January 1, 1930. Has endorsement of the citizens nonpartisan school committee and numerous civic and community clubs. Born in Hamilton county, 1877, where his ancestors were pioneer settlers of Indiana. Came to Indianapolis forty-two years ago. Is president, treasurer and manager of the Knott Bros. Inc. which business he has been for twenty-five years. Is a Mason, a member of the Indianapolis Advertising Club, Citizens Club and Indianapolis Cyclopath. He has never been a candidate for public office. Is interested in the Boy Scouts' movement and has been active in behalf of the Community Fund. Lives at 1115 Fall creek boulevard.

Russell Wilson—Indorsed by citizens nonpartisan school committee and other civic organizations for election to the school board for term dating from January 1, 1930, came to Indianapolis twenty-five years ago where he was graduated from Indiana University law school. Has practiced law in Indianapolis for twenty years. Is married and has two children, ages fourteen and fifteen, who attended the public schools. Is a Methodist, vice-president and member of the board of managers of the Indianapolis Bar Association, and also is a member of the Indiana Bar Association and the Gray and White Association, and the City Council in 1921 during the administration of Charles W. Jewett. He has been active in behalf of the Boy Scouts and Girl Scouts. Lives at 23 Maple court.

Merle Sidener—Candidate for the school board, with the indorsement of the citizens nonpartisan school committee and various community and civic organizations. Four-year term to date from January 1, 1932. Was born in Crawfordsville fifty-eight years ago, and came to Indianapolis forty years ago, where he was educated at Shortridge High School and Butler College. He is the head of the Sidener, Van Riper & Keeling Advertising Agency. Is a Republican, a member of the Third Christian church, the Indianapolis Retiree Club, Chamber of Commerce and director of the National Better Business Bureau. Founded the Christian Men Builders, a Sunday school organization, fifteen years ago, and has become widely known through radio transmission of his Bible class talks. He lives at 4248 Park avenue. Is married and has one daughter.

Samuel E. Garrison—Candidate for school board for the term dating from January 1, 1932, with the indorsement of the citizens nonpartisan school committee and civic and community organizations. Was born in Jewell county, Kansas, in 1885, and has been a resident of Indianapolis for twenty years. Is a graduate of the Indiana Law School and has been an attorney for the last twenty-two years. Is a member of the Seventh Presbyterian church, served on the board of the Indianapolis Church Federation and was president of the Marion County Council on religious education. Has never been a candidate for public office. Served on the local advisory board, and as special agent during the war. Was first deputy prosecutor of Lawrence township, served in a similar capacity in Marion county Juvenile court and was assistant to Frederick VanNoy when he was United States district attorney. He lives at 2630 Allen street, on the south side.

Andrew J. Blucher—Candidate for school commissioner for term beginning January 1, 1930. Has lived in Indianapolis practically all his life and was educated in the schools here. Is now superintendent of rolling stock of the Capitol Dairies, Inc., and previously was a machinist in the Big Four railroad shops at Beech Grove. Is a member of the Masonic order and of fraternal organizations. Lives at 3801 East Thirtieth street. Has one son, William Blucher, also employed at the Capitol Dairies.

Mark E. Gray—Candidate for election to school board post to be filled January 1, 1930. Is co-publisher of the Indianapolis Commercial and editor of the Hooper Moses, the publication of the Moses Lodge. Is a Mason and a Shriner. Has four children, three of whom attend school in Irvington. Lives at 5621 Beechwood avenue. A few years ago was a candidate for county recorder on the Democratic ticket.

Ernest K. Marker—Candidate for school commissioner to take office, January 1, 1930. Came to Indianapolis from Noble county, his birthplace, in 1904, and since then has operated a drug store at 785 Virginia avenue. Attended Notre Dame University and was graduated from Annapolis college with a Ph.D. degree. He has been active in Democratic politics for twenty-five years although he has never held public office. He is married, has two children and lives at 639 East McCarty street.

Mrs. J. B. Rose—Candidate for term on the school board, dating from January 1, 1930. Was born in Chicago, but lived in Indianapolis for many years. Will complete a four-year term on the park board January 1. Has long been active in politics in Indianapolis and has served as vice-chairman of the Seventh district Republican committee and as vice-chairman of the First ward of the Coffin organization. She attended Central Normal College. Is a member of the First United Brethren church and has been active in certain types of civic work. Lives at 1728 Brookside avenue.

Mrs. Lillian B. Moore—Candidate for school commissioner to take office January 1, 1930. Born in Terre Haute, was educated in the public schools of that city, attended DePauw University and was graduated from Hollins College at Hollins, Va. She taught school at Norfolk, Va., and in a private girls' school at Stamford, Va. Wife of Bloomfield E. Moore, chief engineer for the Union Engineering Company. Is a member of several women's organizations. Is vice-chairman of Coffin's Warren township organization. Lives at 289 Burgess avenue.

Mrs. Edna Mellett—Candidate for school board position to be filled January 1, 1930. She has been a resident of Indianapolis for more than twenty-five years. Is identified with the Indianapolis Printing Company, which took over the Mellett Printing Company of which her husband was president. She lives at 2630 Washington boulevard.

Lewis E. Whiteman—Candidate for re-election to the school board for four-year continuance of office beginning January 1, 1932. Is a member of the present majority faction of the present board. Attended township schools at New Augusta. Since living in Indianapolis has been in the insurance business. He has several children, including a son and a daughter who are employed in the school system. Several relatives of his also are employed in the schools. Lives at 801 York street. Supported by Coffin workers in 1929 election.

Fred Keppner—Candidate for re-election to the school board for another four-year term dating from January 1, 1932. Is a member of the majority faction of the present school board. Has several relatives who are employed in the school system. Is connected with the Link Bell Company. At one time was in validsville. Lives at North Mount street. Supported by Coffin workers in 1929.

Mrs. Lillian Sevelick—Candidate for re-election to the school board, re-novating four-year term from January 1, 1928. Is the leader of the majority faction of the present school board. Has two daughters. One of the daughters, the husband of the other one, and other relatives of Mrs. Sevelick are employed in the school system. She lives at 303 Maple road. Was supported by Coffin workers in 1925.

Charles W. Kern—Candidate for re-election to the school board, dating from January 1, 1932. Is leader of the minority faction of the present school board and president of the board, having been elected to that position when he was heading the majority group. Is secretary of the Plumbers and Steamfitters' Union and president of the Building Trades Council. His father and a cousin are employed in the school system. Lives at 1207 Encinal avenue. Supported by the Coffin workers in 1929.
